

**DARLINGTON BOROUGH COUNCIL (PUBLIC FOOTPATH 6 HURWORTH)  
DIVERSION ORDER NO.2 2024**

**NOTICE IS GIVEN** that the above named Order made on the 3<sup>rd</sup> May 2024 under section 119 of the Highways Act 1980 was confirmed on the 11<sup>th</sup> June 2024. The effect of the Order will be to divert the length of public footpath described in Part 1 of the Schedule to the route described in Part 2 of the Schedule below. The route of the footpath runs through land at Rose Villa, Timmy's Lane, Hurworth, Darlington DL2 2AJ and can be seen marked on the Order Map. The changes shall take effect from such date as Darlington Borough Council has certified that the replacement footpath as described in Part 2 of the Schedule is constructed to the Council's satisfaction and is available for use. If a person aggrieved by the Order desires to question its validity, or that of any provision contained in it, on the grounds that it is not within the powers of the above Act, or on the ground that the requirement of that Act or any regulation made under it has not been complied with in relation to the confirmation of the Order, they may apply to the High Court for any of the purposes within six weeks from the date of this Notice.

**NOTICE IS ALSO GIVEN THAT** the Darlington Borough Council (Public Footpath 6, Hurworth) Diversion Order 2024, made on the 4<sup>th</sup> March 2024, notice of which was given on the 7<sup>th</sup> March 2024, will not now be confirmed.

**PART 1**

**DESCRIPTION OF SITE OF EXISTING FOOTPATH**

Footpath No. 6 Hurworth - Starting at Point A, NZ 31203 10276 heading north east through bushes, a garden and a building before proceeding through two hedge lines and finally cross field to Point E at NZ 31309 10347. The width is undefined

**PART 2**

**DESCRIPTION OF SITE OF NEW FOOTPATH**

Footpath No. 6 Hurworth - Starting at Point A, NZ 31203 10276 along a farm track north toward Point B, NZ 31210 10370. From there moving just off the track on to the verge to the east of the track. Then continuing north running parallel to the track toward Point C, NZ 31215 10394. From there proceeding east along the south side of the boundary with Brookside Farm to Point D, NZ 31237 10392. Then running south east to Point E, NZ 31265 10362 across the field. Then continuing east south east toward the east boundary of the field at Point F, NZ 31309 10347 where it rejoins the existing line of the public footpath. The width is 1.5 metres
