Darlington Borough Council Consolidated Traffic Orders

NOTICE is hereby given that on the 4th December 2024 Darlington Borough Council made the following orders in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) ('the 1984 Act') and Traffic Management Act 2004 ('the 2004 Act') and all other enabling powers:

- 5. Darlington Borough Council (Moving Traffic) Consolidation Order 2024 under sections 1, 2, 4 and 84 and Part IV of Schedule 9 to the 1984 Act the effect of which has consolidated into one single order the provisions contained in the orders set out in Schedule 5 below.

The above orders have not made any changes to restrictions currently in force or introduced any new restrictions. The orders shall take effect as from the 9th December 2024. Copies of the Orders are available for inspection between the hours of 9.00am and 4.30pm during weekdays at the Council Offices at Town Hall, Darlington. If any person wishes to question the validity of the orders or any of their provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984 or the Traffic Management Act 2004 or that any requirement of a statutory instrument made under the aforementioned Acts has not been complied with, that person may do so by application to the High Court within 6 weeks from the date of the Order.
